
Assembly Instructions for Models 12EWDH-S-IN, 12EWDH-M-IN, 12EWDH-L-IN

IMPORTANT INFORMATION


Unwrap and remove all parts from the box. Keep the box and packing material until the product is assembled. ASSEMBLY INSTRUCTIONS


1. Expand the insulation kit by unfolding it until the rectangle shape is formed. Set the removable pad aside.



2. Open the roof of the folding wood doghouse. Lower the insulation kit down into the house, aligning the door opening of the kit with the door of the doghouse. Slip the elastic corners over the front corners of the doghouse.



3. With the roof in an upright position, guide the hook and loop straps and lip of the insulation kit through the space between the roof hinges. Secure the hook and loop straps around the hinges. Slip each elastic corner in the back over the back corners of the doghouse.



4. Place the removable pad inside the bottom of the insulation kit and close the roof of the doghouse.
