



ASSEMBLY INSTRUCTIONS

 Place the Washer (J) over each of the Long Screws (I). Push the Washer and Screws up through the bottom of the Base (A). Twist the two Long Posts (D) and one Short Post (E) onto the screws and secure them to the Base. Place a Dual Screw w/ Uneven Threads (L) into the Short Post. The short threads should point upward.







2. Twist the Small Platform (C) onto the Short Post. Place the Bolstered Pillow (H) on the circular Platform and secure with the drawstring.


Place a Dual Screw w/ Even Threads (K) into each of the Long Posts (D). Slip the Large Platform (B) over the two Dual Screws.

 Twist the second Small Post onto the Dual Screw as shown. Then, place a Dual Screw w/ Uneven Threads (L) into the top of the Small Post and twist the Cat's Eye platform onto the top of the post.

4. Twist the Medium Post (F) onto the second Dual Screw as shown. Then, place a Dual Screw w/ Uneven Threads (L) into the top of the Medium Post. Twist the second Small Platform into place on the Medium Post, and place the Bolstered Pillow (H) on the Small Platform and secure it in place with the drawstring.










To clean your Feline Nuvo Cat Furniture, wipe with a damp cloth. Do not submerge or spray with water as this will damage the structure.

Replacement parts are warranted for the remainder of the original period.
- 2. THIS WARRANTY DOES NOT COVER defects in the furniture caused by any animal, any physical abuse to or misuse of the pet furniture, any damage caused by the original purchaser or any third party, or any defects arising or discovered more than one (1) year from the original retail purchase date.

3. STEPS TO OBTAIN WARRANTY SERVICE:

No returns or replacements will be permitted without proper authorization.
