Assembly Instructions for Model Number K9664

IMPORTANT INFORMATION

Warning: Remove collars, tags, and leads from pet before placing it in the kennel to prevent possible entanglement. DO NOT leave young animals unsupervised for extended periods of time. Helpful Hints

Please take time to read and follow these instructions. To make set-up easier, locate a level area to assemble your kennel. Remove all components from the carton and arrange them as shown on Page 2. You will need a pair of pliers and an adjustable wrench to assemble your kennel. We recommend two people assemble the kennel together.

The chain-link fence comes in one continuous 24' piece. It is prone to tangle while attaching, but with two people and a little patience, the fence can applied with minimal complication. The best practice is to unroll the fence and stretch it out completely to undo any tangling. Then, using two people, lift, pull, and stretch the chain-link fence around the perimeter one small section at a time.

Sunscreen Safety

Your K9 Kennel comes with a Sunscreen. We suggest removing and storing the Sunscreen when not needed to shade your pet. Do not allow snow or debris to collect on top of the Sunscreen. Occasionally, even rain will collect. Remove it as soon as possible. Injury to your pet and damage to your Kennel may occur if the load is not removed. Properly cared for, your Sunscreen will provide years of service and protection for your pet.



PARTS IDENTIFICATION


- A. Bent Bottom Rail with short corner peg two rails have no swaged ends; two rails have one swaged end (4)
- **B.** Long Filler Rail two rails have two swaged ends; two rails have one swaged end (4)
- C. Short Filler Rail swaged on one end (4)
- D. Bottom Gate Rail swaged on all ends (1)
- E. Gate Door (1)
- F. Gate Frame Vertical Posts swaged on one end (2)
- G. Top Gate Rail (1)
- H. Vertical Corner Posts swaged on one end (4)

- I. Bent Top Rail with long corner peg two rails have no swaged ends; two rails have one swaged end (4)
- J. Vertical Tension Rod 5/16th Diameter (2)
- K. Chain-Link Fence (1)
- L. Sunscreen Top (1)
- M. Short Plastic Ties (40)
- N. Long Plastic Ties (24)
- O. Scored Eyebolt with Nut (6)
- P. Black Plastic Cap (6)


Swaged End - Reduced, Smaller Diameter

The Vertical Corner Posts (H), the Short Filler Rails (C), two Long Filler Rails (B), two Bent Top Rails (I), the Gate Frame Vertical Posts (F), and two Bent Bottom Rails (A) have one swaged end. Two Long Filler Rails (B) have two swaged ends. The Bottom Gate Rail (D) is swaged on all ends.





 Place the following pieces on the ground as shown: four Bent Bottom Rails (A) on the corners. The small pegs on the Bent Bottom Rails must point up. In the back, use two Long Filler Rails (B) to connect the corners. Notice the placement of the swaged ends. In the front, place two Short Filler Rails (C), the Bottom Gate Rail (D), and the Gate Door (E) as shown. Note the placement of the swaged ends on each rail.



2. Push the swaged ends of each rail into the non-swaged ends of each adjacent rail, making sure all pieces are pushed in completely and put together firmly.

 On each corner, push the non-swaged end of a Vertical Corner Post (H) onto the short corner peg of each Bent Bottom Rail. Lay the Gate Frame Vertical Posts (F) and the Top Gate Rail (G) as shown.



4. Push the non-swaged ends of the Gate Frame posts (F) onto the Bottom Gate Rail, then connect the Top Gate Rail (G) to the swaged ends of the Gate Frame Posts.




5. Swing the Gate Frame into the upright position. Starting at the corner closest to the Gate Frame. Use a Short Filler Rail (C) to connect the Gate Frame and a Bent Top Rail (I) with NO swaged ends. Place the long peg on the Bent Top Rail over the Vertical Corner Post.



- 6. Locate a second Bent Top Rail (I) with one swaged end and one non-swaged end. Connect this to the first Bent Top Rail and slide over the Vertical Corner Post in the back.
- **7.** Connect a Long Filler Rail (B) with two swaged ends to the Bent Top Rail.



8. Using the last Long Filler Rail (B) with one swaged end, connect the Filler Rail from Step 7 to a Bent Top Rail (I) with one swaged end. Slide the Bent Rail over the Vertical Corner Post in the back.




9. Use the last Bent Top Rail (I) with no swaged ends and a Short Filler Rail (C) to complete the top rail.



10. With the Gate door open, insert the Eyebolts (0), with the eye to the outside of the kennel, through the six holes in the Gate's frame (three on each side). Start the Nuts onto the end of the bolts about 1/4" as shown. **WAIT to tighten all the way.**

11. NOTE: At this point, you will begin attaching the chain-link fence (K). The chain-link fence comes in one continuous 24' piece rolled in plastic to help prevent tangling and bunching. While attaching, remove the plastic as you go. With two people and a little patience, the fence can applied with minimal complication. The best practice is to unroll the fence and stretch it out completely to undo any tangling. Then, after Step 12 and using two people, lift, pull, and stretch the chain-link fence around the perimeter one small section at a time. About every two feet, you will loosely attach a SHORT Plastic Tie (M) to keep the chain-link in place until it is ready to be fully secured.



12. Stand one end of the Chain-Link Fence (K) up against the left side of the Gate frame. Starting at the top, thread the Vertical Tension Rod (J) down through the Chain-Link Fence, front/back, front/back, through each diamond, while making sure to pass <u>through</u> the eye of each Eyebolt on the way down. Thread the rod all the way through the last diamond at the bottom.





13. Unroll the Chain-link Fence around the frame of the kennel, being sure to keep tension on the wire by pulling the roll as you unwind it. Occasionally, it may be necessary to untangle the knuckles at the top and bottom of the roll. Keeping the tension on the roll tight will help prevent this.



NOTE: As stated on page 6, with two people the fence can be fully unrolled, stretched out in its entirety, and lifted, pulled, and stretched around the perimeter one small section at a time. This will minimize bunching and tangling of the fence during application.

14. About every two feet, loosely attach a Short Plastic Tie (M) at the top to keep the chain-link in place until it is ready to be fully secured.





NOTE: After you have unrolled the Chain-Link Fence completely around the frame, you may find that you have several extra inches of chain link that extends past the last set of Eyebolts. This excess must be removed. Pull the Chain-Link Fence tightly past the Eyebolts to determine where to remove the extra fencing so that the second Tension Rod (J) can be installed in Step 18.


15. To determine how much Chain-Link Fence to remove, slide the second Vertical Tension Rod (J) down through the Chain-Link Fence so it will pass through the eye of the first Eyebolt. It is the extra Chain-Link Fence on the <u>Gate side</u> of the Tension Rod that must be removed. Locate and note the top knuckle of the fence on the Gate side of the Tension Rod. Remove the Tension Rod for now.

16. Unbend the loop of the knuckle you identified until it is straight. Locate the corresponding knuckle at the bottom of the Chain-Link Fence. Unbend that loop.

17. This single "picket" can now be removed. Lift and rotate the picket until it is completely removed from the fencing.










18. Once all excess fencing has been removed, reinsert the second Tension Rod (J) down through the Chain-link Fence and the Eyebolts on the other side of the gate, as you did in Step 12.





19. Facing the Kennel, go to the top, left Eyebolt. Push the "eye" firmly against the Gate Frame. Tighten the Nut past the scored area of the bolt's threads. Move down to the next Eyebolt and repeat. Pulling the Tension Rod against the Gate Frame as you go, proceed around the Gate Frame until all eight Eyebolts have been tightened. This step will tighten the fit of the Chain-Link Fence around the frame.

Use pliers to grip the exposed threads and snap off the excess at the scored area of the bolt. Finish each nut with a Plastic Cap (P).



20. Starting at the Gate Frame, install Short Plastic Ties (M) every two feet on the top rail, securing the Chain-Link Fence to the Top Rail of the Kennel. Do the same with the Bottom Rail, installing the ties <u>with</u> <u>closer spacing, approximately every</u> <u>12 inches</u>.





Sunscreen Installation

Unfold the Sunscreen (L) and, using the Long Plastic Ties (N), loosely attach it to the Bent Top Rail of the Kennel at <u>each corner</u>. **DO NOT PULL THEM TIGHT!**



After the corners have been attached, loosely affix a Long Plastic Tie at each grommet on the Sunscreen around the perimeter. Starting at one corner, pull the tie a bit tighter. Work your way around to each corner, pulling the ties tighter and tighter until they are all snug. Now work your way around the kennel, pulling the remaining ties up as you go.
