## Assembly Instructions Parrot Playstand

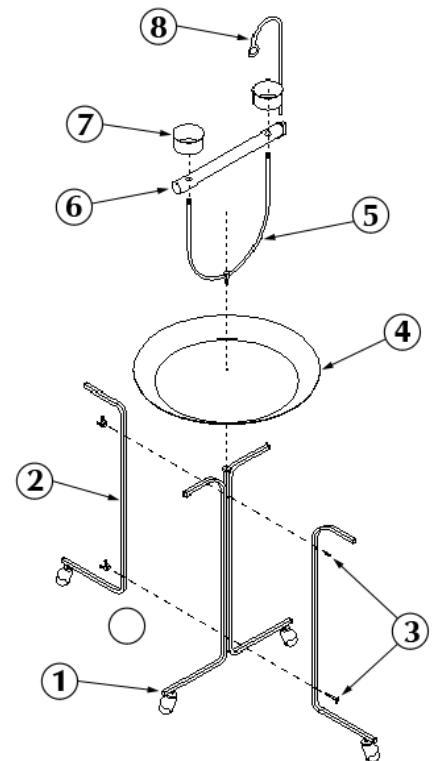

### Assembly Instructions

- ① Take the fused DOUBLE LEGS and hold them up while simultaneously putting both of the two SINGLE LEGS on either side (as shown) perpendicular to the DOUBLE LEGS.
- ② Line up the hole at the top of each SINGLE LEG to the hole at the top of the fused DOUBLE LEGS and insert one screw through all three parts. Tighten the legs together by screwing the wing nut onto the end of the screw until all three parts are held tightly together.
- ③ Repeat Step 2 with the holes near the bottom of each LEG part.
- ④ Line up the hole in the center of the TRAY with the center of the fused DOUBLE LEGS.
- ⑤ Take the U-FRAME/HARP and insert its attached screw through the hole in the center of the TRAY and into the female receptacle at the top/center of the fused DOUBLE LEGS. Turn the U-FRAME/HARP to the right until it has been tightened sufficiently and does not wobble.
- ⑥ Take the PERCH and insert it so that the U-FRAME/HARP ends fit through the holes in the perch.
- ⑦ Take each CUP and screw the bottom of each cup into the ends of each U-FRAME/HARP.
- ⑧ Attach the TOY HOOK/HOLDER into the sleeve on the end of the perch.

  - C. MidWest may require the purchaser to present the sales receipt or other proof of purchase prior to authorizing any return or replacement. No returns or replacements will be permitted without proper authorization. If a return or replacement is authorized, you may be requested to return the item to MidWest or to make the item available for pick-up by MidWest.
