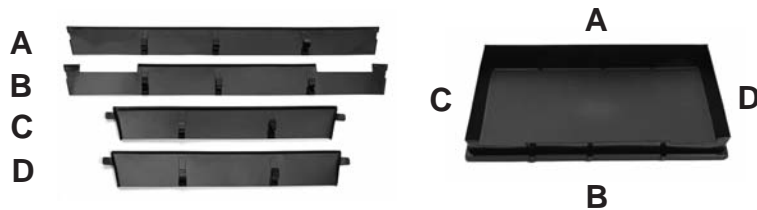
Assembly Instructions for Model Number NA-SGL (Fits MidWest's Ferret Nation and Critter Nation)

### IMPORTANT INFORMATION

Unwrap and remove all parts from the box. Keep the box and packing material until the product is assembled. In case of return or exchange, failure to return product in similar condition as received could result in limited reimbursement. Please save sales receipt as proof of purchase for warranty purposes. Scatter Guard Lower Level (4 pieces)

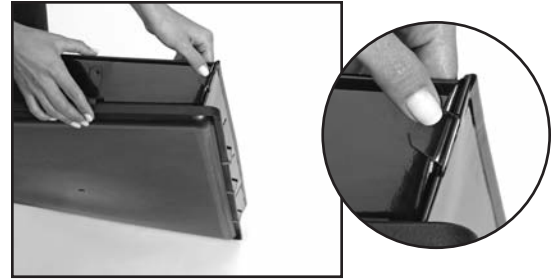


### ASSEMBLY INSTRUCTIONS

1. Match each piece of the Guard to the appropriate side of the plastic pan. On the Lower Level Scatter Guard, the two notched cutouts go in the front of the cage to allow easy access for your pet to use an external ramp. Attach one piece of the Guard so the clips on the Guard fit over the outer lip of the pan.
2. Attach the next Guard piece to the pan, then connect the two Guard pieces together by inserting the tab into the opening on the adjacent Guard piece.



- Secure the two pieces together by folding the tab over as shown.



- Attach the remaining Guard pieces and secure them together as shown in steps 1-3. The Scatter Guard is now complete and the pan can be placed in the lower level of your Ferret Nation or Critter Nation cage.
